5/29/07 Andre Mark Sentenced to Maximum Penalty for Third-Degree Murder

MEDIA- Assistant District Attorney William Davis, on behalf of Delaware County District Attorney G. Michael Green, prosecuted Andre Mark on the charge of third-degree murder. 19-year-old Andre Mark and his co-defendant 17-year-old Christopher McEaney beat Martin Malone with a shovel and stabbed Malone eight times while Malone was outside an apartment complex in Upper Darby. After a jury found Andre Mark guilty of third-degree murder, Judge Patricia Jenkins sentenced Andre Mark to 20 to 40 years of imprisonment, the maximum penalty for third-degree murder in the Commonwealth of Pennsylvania.

5/25/07 Saunders Convicted for First-Degree Murder

MEDIA- Assistant District Attorney Christopher DiRosato, on behalf of Delaware County District Attorney G. Michael Green, prosecuted Clarence Saunders on the charge of first-degree murder. After Saunders chased Brian Dickerson down a Chester alleyway, Saunders shot Dickerson with seven bullets. After hearing hours of testimony and reviewing the evidence which revealed a love triangle between Saunders, Dickerson and a woman, a jury convicted Saunders of first-degree murder. Saunders faces a mandatory sentence of life in jail. Sentencing is scheduled for June 12, 2007.

5/18/07 Drug Dealer Faces Six Years of Imprisonment for Drug Trafficking Convictions.

MEDIA- Assistant District Attorney Mary Mann, on behalf of Delaware County District Attorney G. Michael Green, prosecuted Jesus Martinez on several charges of possession of a controlled substance with the intent to deliver. A jury convicted Martinez, a prolific drug dealer in the City of Chester, on two counts of drug trafficking. As a result of ADA Mann's efforts to prosecute one of Chester's notorious drug dealers, Martinez is exposed to two separate three-year mandatory minimum sentences of imprisonment.

### 5/8/07 Healthcare Worker Pleads Guilty After Stealing from Handicapped and Elderly

MEDIA-Deputy District Attorney Gregory Hurchalla, on behalf of Delaware County District Attorney G. Michael Green, prosecuted Antoinette Colclough on charges of theft by deception, identity theft, and access device fraud. As a healthcare worker, Colclough stole over \$29,000 from her clients who included a 49-year-old paraplegic, a mentally disabled man, and an elderly woman. Colclough used the personal information of her victims to open fraudulent accounts at American Express, Wal-Mart, Home Depot, Dell Computers, and Victoria's Secret. Colclough plead guilty to felony identity theft and felony access device fraud. Sentencing is scheduled for June 19, 2007.

### 5/7/07 McEneaney Sentenced to Life in Jail for Stabbing Upper Darby Man

MEDIA- Assistant District Attorney William Davis, on behalf of Delaware County District Attorney G. Michael Green, prosecuted Christopher McEneaney on the charge of first-degree murder. 17-year-old McEneaney and his co-defendant 19-year-old Andre Mark beat Martin Malone with a shovel and stabbed Malone eight times while Malone was outside an apartment complex in Upper Darby. After a jury found McEneaney guilty of first-degree murder, Judge Patricia Jenkins sentenced McEneaney to a mandatory life sentence.

### 5/3/07 Upper Darby Drug Dealer Convicted

MEDIA-Assistant District Attorney Brian Doherty, on behalf of District Attorney G. Michael Green, prosecuted Carl Gould on the charge of possession of a controlled substance with the intent to deliver. After the Commonwealth offered expert testimony to establish that Gould was in possession of individually packaged cocaine for drug trafficking purposes, a jury convicted Gould of possession of cocaine with the intent to deliver and of other drug related offenses. Gould faces a mandatory minimum sentence of three years of imprisonment.
