PHILADELPHIA – United States Attorney Laurie Magid and Delaware County District Attorney G. Michael Green announce that on March 3, 2009, U.S. District Judge Juan R. Sanchez sentenced Daniel James Naylor, 35, of Chester, PA, to a 10-year federal sentence followed by 3 years of supervised release, a \$1,000.00 fine and a \$100.00 special assessment fee. On June 22, 2007, Naylor pled guilty to a one-count indictment for the federal crime of Felon in possession of a firearm. Naylor has been previously convicted of two separate drug trafficking offenses in the City of Chester, and one additional drug trafficking offense on the I-95 corridor in Tinicum Township, Delaware County, PA. In addition to other criminal convictions, in 1995, Naylor was convicted for the Pennsylvania crime of Firearms Carried without a License.

On April 11, 2006, in area of Highland Avenue, Route 291 and Hayes Street, Chester, PA, Police Officers Joseph Greenwalt, Steven Rosinski and James Carr conducted a motor vehicle stop of Naylor's automobile after Officer Greenwalt observed Naylor commit several motor vehicle code violations. After an arrest of Naylor and his passenger for possession of drug paraphernalia and marijuana, the police recovered two firearms from Naylor's glove box, a Bryco Arms .38 caliber semi-automatic pistol, with one live round of ammunition in the chamber and one live round of ammunition in the magazine; and a Phoenix Arms 22 caliber semi-automatic pistol, with one live round of ammunition in the chamber and eight rounds in the magazine. During booking, Naylor told Officer Greenwalt, "Yo, man, both guns are mine."

This indictment is part of Project Safe Neighborhoods, an initiative by the United States Attorney's Office, Delaware County District Attorney's Office, the Bureau of Alcohol, Tobacco, Firearms and Explosives, and the City of Chester Police Department. Chester Police Officers Joseph Greenwalt, Steven Rosinski, and James Carr made the initial arrest. B.A.T.F. Special Agent Barry DeProsperis investigated the case for the federal indictment. Special Assistant United States Attorney (Delaware County Assistant District Attorney) James Halligan prosecuted the case.
